

Factors Contributed in Bringing Change Progress

- People's Movement I for Democracy Ended absolute monarchy - party less democracy in 1990
- Maoists movement for republican state 1996 to 2006 (an armed conflict) 1996 to 2006 resulting Comprehensive Peace Accord

- - Enshrine the principle of inclusiveness
 - Ensured proportional representation
 - Adoption of the First past the Post and Proportional Representation election system

- Madhesi (31.2%),

- Dalits (13%),
- Indigenous (37.8),
- backward regions (4%), and

Salient Features: The Constitution 2015 – FDR of Nepal

Ensured minimum 33% women at Local, Provincial and Federal

- Reserved 40% seats (Including 1 Dalit) at Ward Committee
- Rural Municipality Chair and Vice-Chair must be a woman
- Municipality Chief and Deputy-chief must be a woman
- Either the president or vice-president must be a woman.
- Speaker of deputy speaker of the parliament must be a woman








